14/11/12	Wednesday	KLM Royal Dutch Airlines announced double daily return flights between Manston and Schiphol Hub, Amsterdam, with onwards connections to the rest of KLM's network. The first flight was with a Fokker 70 on 2 April 2013.
15/10/13	Tuesday	Infratil announced they would sell the airport to a company wholly owned by Ann Gloag, co-founder of Stagecoach Group.
29/11/13	Friday	Manston Skyport Ltd. took over the running of the airport. Ms Gloag said: " <i>Whilst this is a loss making airport, I hope that with the co-operation of our neighbours and the wider community of Kent, the airport partners and staff, we can capitalise on the opportunities available to give Kent the best chance possible of having a successful and vibrant airport.</i> " She pledged to deliver " <i>real potential for growth</i> ", and promised that she would commit to the airport for two years.
19/03/14	Wednesday	The government announced financial support for new air-routes from regional airports.
19/03/14	Wednesday	After a period of 5 months 2 weeks 2 days Ms Gloag announced that a 45-day " <i>consultation</i> " period into the closure of the airport had begun. KLM, Newmarket and cargo flights were forced to end. The Closure " <i>Consultation</i> " appears to have just been an exercise of " <i>Informing</i> ", mainly through the media. The key Airport Consultative Committee (KIACC) meeting during the closure " <i>consultation</i> " appears to have been deferred until after Manston Airport was closed.
09/04/14	Wednesday	The last KLM flight departed for Amsterdam. In all, about 48k passengers had been flown to and from Schiphol Hub, Amsterdam, and international destinations.

15/05/14	Thursday	In a dramatic twist on the airport's last day, Eastenders star Cliff Parisi (Minty) has to make a forced landing whilst on a light aircraft flight to France.
15/05/14	Thursday	Offer of full asking price by USA company RiverOak turned down. Manston Airport was shut by the current owner at 5pm. A large orderly demonstration took place at the airport. The airport closed at 5pm along with the loss of 144 jobs. A NOTAM (Notice to Airmen) was also issued at closure stating that the Aerodrome has been "completely withdrawn". http://en.wikipedia.org/wiki/NOTAM
26/06/14	Thursday	A petition with about 7,700 signatures, to support a compulsory purchase order to preserve Manston Airport for aviation purposes, was presented to Thanet District Council (TDC) : <i>"We the undersigned petition the council to make a compulsory purchase of Manston, Kent's International Airport. We would also like Thanet District Council to look into the possibility of members of the public to buy bonds into this purchase."</i> "In addition to the 3,361 persons who have signed the Epetition, 4,330 persons have validly signed a paper petition containing the same petition prayer as the Epetition." So about 7,700, well over the required 1000 signatures necessitating a full council meeting.
07/07/14	Monday	£10m Government funding for a Thanet Parkway station possibly on the Manston Airport boundary announced by KCC.
09/07/14	Wednesday	TG Aviation, who have been at Manston Airport for 30 years, and have 50 years remaining on their lease, failed to gain an injunction in the High Court, which would have allowed them to use the runway. The full case will be heard "soon". SMA hold their inaugural Special General Meeting.
10/07/14	Thursday	The full Thanet District Council (TDC) held a meeting about giving consent to the TDC Cabinet to investigate raising a Compulsory Purchase Order (CPO) on Manston Airport, and this received nearly unanimous approval. Full notice of motion: <i>"Council affirms its considerable disappointment at the recent closure of Manston as a regional airport. We recognise the public support for its continuation as an airport and endorse the steps taken to date towards that objective. Council urges all available options to that end be explored, including a detailed examination of the legal and financial implications of a Compulsory Purchase Order before a final decision is reached."</i>
17/07/14	Thursday	Kent County Council (KCC) held a Council Meeting, and unanimously supported : <i>"Kent County Council supports the actions taken so far by Thanet District Council to retain Manston as a regional airport. We recognise the value that a regional airport brings to East Kent and are disappointed at its closure. Kent County Council will explore with Thanet District Council ways in which it can support proposals to retain Manston as an airport."</i>
17/07/14	Thursday	The same afternoon the TDC Cabinet held an extraordinary meeting about the CPO : <i>"To inform the Cabinet of the timeline for identifying an indemnity partner in the event a CPO is sought for Manston Airport. To explain the process of a local authority bond issue."</i> The council agreed to continue to investigate the CPO proposal. The aviation minister, Robert Goodwill, has told the House of Commons that the department of transport is <i>"more than happy to help with any Civil Aviation Authority (CAA) licensing issues"</i> relating to the future of Manston Airport.
21/07/14	Monday	A petition was presented to 10 Downing St, by the Thanet MPs Sir Roger Gale and Laura Sandys, TG Aviation and the Save Manston Airport group. This petition had 26,524 signatures in support of re-opening Manston as a working airport :

We have flights on our doorstep, it will create more jobs and if the powers that be are thinking of spending money on improving rail networks for the area it will tie in nicely with Manston Airport.”</i>
23/07/14	Wednesday	Dover District Council unanimously voted to support the motion : <i>"This Council supports the campaign to retain Manston as an operational airport, recognising the role and place it can have in the UK aviation industry, making better use of the regional capacity in accordance with the views of the South East Local Enterprise Partnership, while making a significant contribution as one of the strategic priorities for regeneration of the East Kent area."</i>
24/07/14	Thursday	USA company RiverOak write a long letter with 2 legal addendums to TDC leader Iris Johnston, offering to buy/run the airport and fully cover purchase price and CPO costs. RiverOak state they have developed a long term plan to own and manage Manston as an airport. <i>“We are firm in our belief that Manston has a viable future across many lines of air freight, aviation services including maintenance, recycling, private charter and commercial passenger services.”</i>
30/07/14	Wednesday	Airport operating equipment auction by the owner, about 700 lots. X-Ray baggage scanners have been sold, fire-engines and generators have been sold. Auction continued on 31st July
31/07/14	Thursday	TDC Cabinet Meeting : The preliminary findings of an independent report (Stage 1) (Falcon report), which consider the viability of Manston Airport, were discussed. Cabinet accepted the report and have agreed the following: The commissioned viability report will be shared with the airports owners. Cabinet will instruct officers to proceed to Stage 2 of the viability assessment to develop a high level Business Plan – which would be necessary to support the Local Plan process and any potential future procurement for an appropriate investor/partner. Cabinet will also instruct officers to undertake a market testing exercise to establish the level of interest, in line with the conclusions in the independent report – before starting a full procurement process. (Note: This is the point at which RiverOak, who wish to buy the airport for aviation purposes, may formally enter the process by asking to be Indemnity Partner – i.e. the guys who pick up the tab.) A decision regarding compulsory purchase of the airport will not be made until an Indemnity Partner is identified following the procurement process.
06/08/14	Wednesday	TDC issued the Prior Information Notice (PIN). Forward planning allows the placement of a PIN in the journal and shortens the timescales. What does this mean in practice? Basically, the clock for the CPO process is now ticking. The CPO process can still be stopped, and stringent checks must still be made before the CPO is issued. TDC received a number of applications to be the Council’s Indemnity Partner for the CPO to return Manston Airport to Aviation use. RiverOak formally submitted their wish to be recognised as the TDC indemnity partner.
09/09/14	Tuesday	Ex Air Traffic Controller, staff and a tenant slam incompetent Manston management

18/09/14	Friday	Minister without Portfolio and Conservative party co Chairman Grant Shapps visits TDC for talks. Afterwards makes a speech offering Government support at Manston Airport
25/09/14	Thursday	A further auction of vital operational equipment such as Control Tower, Airfield Lighting & Navigational Aids. Of very little value once removed, but leaves the airport unusable without a lot of hugely expensive work to reinstate them, and probably to calibrate and re-certify them. However we hear that the Instrument Landing System (ILS) has not sold, which is very good news.
02/10/14	Thursday	A petition “No to Houses on the Manston Airport site” was presented to Thanet District Council leader Iris Johnston, during a large and very noisy but good natured rally on the TDC steps - about 10,000 signers in all, over 8,000 e-signers, about 2,000 on paper. Reported by BBC.
16/10/14	Thursday	An interim report on the soft-market testing exercise to identify suitable indemnity partners to cover all of the associated costs of a CPO was taken to TDC Cabinet, a further rally taking place.
24/10/14	Friday	Boet E. J. Kreiken, Managing Director KLM Cityhopper, wrote an impassioned letter to ex-Manston Air Traffic Controller, Andy Wilby, making it quite clear that KLM had been forced to leave Manston by the owners closing the airport, and repudiating the suggestion that it was KLM leaving that had caused the closure.
26/10/14	Sunday	In response to an email from an SMA member, the Managing Director of KLM Cityhopper sets the record straight regarding the demise of their service from Manston to Schiphol
27/10/14	Monday	On the weeks Monday 27 th October to Saturday 1 st November, RiverOak flew into Kent, and held at least two meeting with TDC, and it is believed some with Government officials.
01/11/14	Saturday	A “Meet & Greet” session was held between RiverOak and the pro-Manston Airport groups, at TG Aviation premises. Well reported in KM Thanet Extra.
07/11/14	Friday	A television debate was proposed between Chris Musgrave and Trevor Cartner and a Manston supporter – Sir Roger Gale offered to take up the challenge at which point Chris Musgrave and Trevor Cartner backed out. Sir Roger gave a most impressive and hard hitting interview
12/11/14	Wednesday	Hustings meeting – at Discovery Park, chaired by David Foley – Chief Executive, Thanet & East Kent Chamber – Manston Airport discussed - show of hands 95% in favour of Manston re-opening.
18/11/14	Tuesday	2pm a meeting of the Kent International Airport Consultative Committee – incorrect minutes were released, with a number of important errors.
18/11/14	Tuesday	Also at 7pm, TDC Full Council extraordinary meeting.
27/11/14	Thursday	7pm, TDC meeting discussing the Local Plan.
28/11/14	Friday	7:30am – breakfast hustings meeting, again chaired by David Foley. Candidates discussed questions regarding Manston – show of hands from businessmen etc. again about 95% in favour of Manston re-opening.

It would appear that Ann Gloag has sold about three quarters of the airport to two property developers, Chris Musgrave and Trevor Cartner. They appear to have no interest in developing the Manston Airport as an airport (which it is still designated as) but appear to hope they will get permission to dig up the runway (which would currently bring about police intervention) and put in place “mixed development”. Thus the CPO now has to be served on 3 people, not one. We can find no record as to how much was paid, or indeed if there was a payment. All shares seem to still reside with Ann Gloag and her personal company.
